# Multi-Purpose Sand

A graded, washed, dried and sanitized sand for use in sandboxes, gardens, cat litter boxes, ice and snow traction or weight sand. Can also be used as base material for pavers and stepping stones.

**USES:**

- Landscaping
- Pet areas
- Traction in winter
- Between patio pavers and bricks

**STORAGE:**

Store in a tightly closed container off the floor in a dry place.

**COVERAGE:**

60 lbs. provides approximately 0.6 cubic feet (0.016 cubic meters) of sand, or will fill an area approximately 7 sq.ft. x 1 inch (25 mm) deep.

Length x width x depth (all in feet) will give the cubic volume. Divide the cubic volume of the area to be filled by 0.6 cubic feet. This will give the number of bags needed eg. 4 ft. long x 3 ft. wide x 4 in. (.33 ft.) deep = 4 cubic feet divided by 0.6 cubic feet gives the number of bags needed (7) in this example.
